Group 1: Requested that this policy be reviewed and updated annually. Should be reviewed and brought to the Board in the Spring for approval.

Group 2: Thought that the DRAFT was ok, but wished it had more teath to it.

Group 3:

- B&C Professional Development should be "required" not "provided. Believe this could cause issues with the union. Accelerated coursework (including AICE, IM & AP programs).
- K Recruitment should list people of color, LGBTQ, etc.
- F more detail in FS1003.42.
 - Dr. Moore advised we need to get this approved and get through the rough climate right now and then re-review to be more specific in the future.
- 4 hours of compilance training, however if it is just provided, the people who need it will not take
 it. Dr. Moore is working on the Diversity in workforce modules with some staff leaders.
- Several members advised we need to push, not pull back on this Equity Policy. Seeing the board meetings makes it clear we need to keep fighting.
- Advised that we need a balance. If we can push the limit then great, but we need a plan B and
 what we can live with as a group for the policy.
