Visit our school website, click on the RESOURCE tab. Then scroll to the bottom and click on your grade level tab (2021/2022). Fill in the Parking Registration form before you hit print. (Leave the decal number and lot areas blank). Then get the required signatures and scan that form to me at: [Amanda.Mavrikas@sarasotacountyschools.net](mailto:Amanda.Mavrikas@sarasotacountyschools.net) Make sure your email has the following forms attached before sending: SHS Parking Registration Form, Driver's License, Vehicle Registration, Vehicle Insurance card and payment receipt. Once I receive all of this I will email you back a map of the parking lot that you will be assigned to, so you can pick your spot!

Here is the information for purchasing your parking pass. Visit <http://osmsinc.com> or download the OSP online school payments and create an account. Then you will select parking pass to purchase. Before you check out be sure you enter the students FULL NAME and N# in the description box. Parking Decals are \$35.00 plus a fees of \$1.75 for the online service, total of \$36.75. At this time, parking may only be paid for through this app with a Credit/Debit Card.

2. The registration must be delivered to a Tax Collector or Tag Agent for transfer to a replacement vehicle.
3. Your registration must be updated to your new address within 20 days of moving.
4. Registration renewals are the responsibility of the registrant and shall occur during the 30-day period prior to the expiration date shown on this registration. Renewal notices are provided as a courtesy and are not required for renewal purposes.
5. I understand that my driver license and registrations will be suspended immediately if the insurer denies the insurance information submitted for this registration.
